By filling in the form on this page, you provide the controller with your personal data for the purpose of contacting you and sending you a business or other offer. In particular, SiteOne processes personal data collected from prospective customers when they fill in the contact forms on the website. Siteone also processes the data it obtains from the prospect and other individuals by using the SiteOne system or visiting our website: log files (IP address or other online identifiers).

For how long do we process personal data?

Users' personal data is processed for as long as necessary to ensure the security of the service and for email contact by SiteOne.

2. SiteOne is the processor of the personal data

What is the purpose of the processing and how do we handle the data?

SiteOne does not perform any operations with the data of the prospect, including personal data, except for storing it on SiteOne servers, does not interfere with it in any way, does not modify it, does not make it available or transfer it to third parties (except for disclosure to state authorities in accordance with the law). The sole purpose of handling this personal data is to store it and to make it available to the interested party.

3. Recipients and processors of personal data

SiteOne does not transfer personal data to any other controllers. Personal data may be disclosed to government authorities under certain conditions.

4. Rights of data subjects

As a data subject, you have the right to:

(a) to access your personal data;

- (b) to rectification of personal data;
- c) to erasure of personal data;
- (d) to restrict processing;
- e) object to processing;
- (f) to data portability;
- g) lodge a complaint with a supervisory authority;
- (h) for information concerning rectification or erasure of personal data or restriction of processing;
- (i) to be informed in the event of a personal data breach;
- (j) withdraw consent to the processing of personal data.

Your rights are described in detail in the EU Regulation 2016/679 (GDPR). You may withdraw your consent in writing at any time and exercise your other rights as a subject by sending your request to info@siteone.cz.
